Another year is starting and Sharyland WSC is already working on construction projects and improvements to our facilities and waterlines in our area due to the TxDOT road widening and the implementation of our Water Master Plan (WMP). These waterline improvements are necessary to improve pressure and volume for our customers. Our WMP is a 20-year commitment that started in 2020 and is intended to identify infrastructure that needs to be upgraded to ensure projected growth demands in the future.

US Environmental Protection Agency Requirement to Develop a Lead Service Line Inventory

The U.S. Environmental Protection Agency (EPA) issued regulations requiring all public water supply (PWS) systems to develop a Lead Service Line Inventory (LSLI) of both water system owned and privately owned service lines. Sharyland WSC must submit this inventory to the Texas Commission on Environmental Quality (TCEQ) by October 16, 2024.

The LSLI is a mandatory requirement. Representatives from our water system may contact you in the near future to ask you questions to assist us in identifying service line material used in your home's plumbing and service line. Please take the time to respond to our inquiries as this will assist us in submitting this information to the Texas Commission on Environmental Quality as required.
